## A. PURPOSE

The purpose of this policy is to define the requirements for institutional or individual memberships in professional organizations, ic organizations and social clubs that are paid by the University.

## B. AUTHORITY

<u>Social Clubs Organizations/clubs</u> whose mission is to provide social and/or recreational activities for its members (e.g., Norfolk Yacht and Country Club, **Trovint** Club).

## D. SCOPE

This policy applies to alemployeesand students of the University. Employees include all staff, administrators, faculty, fullor part-time, and classified or neclassified persons who are paid by the University. Students include all persons admitted to the University who have not completed a program of study for which were enrolled; student status continues whether or not the University's programs are in session.
